GREEN LAKE COUNTY SNOWMOBILE MESTING Tuesday, Nov. 18, 1975 Attended by William and Lois Kempley, Bill Boderick at the BEL AIR, Green Lake

There had been an ENT program which some of them attended at the Green Lake courthouse, connected with Madison DNR.

Some of the questions that were brought up were:

Free signs were available, flourescent paper. Steel signs were available on a 50-50 basis with DNR.

Ina township, for a lightly used town road, you can apply for DNR funds, signs are available for a SNOWMOBILE ROUTE in connecting club trails.

Villages with open streets for snowmobiling can get signs, The city or town must apply for the signs, DNR will pay. The question was asked, why does it cost more to register a used snowmobile, or one whose registration has run out, the answer was it requires 3 times the processing. (\$10. rather than \$9.)

Green Lake specifies that windshiæld stickers be on the lefthand side for identification when passing head on.

There is a six mile trail from Randolph to ZNAK Cambria which was state funded. Harold LeJeune, Portage, was active in securing this. But coming season submissions are being rejected, in the southern part of the state.

\$27,000. bridges have been built.

Standards are being lowered.

One club built a 40' bridge for \$100., could be state approved if Fish Management approved (removable).

There is available for \$1800., a 50' span bridge, arch type, which can be skidded.

Bev discussed giving free memberships to landowners (payment for use of trail). The AWSC attorney advised that concerning landowners liability (29.68 of Wis. Statutes), any valuable consideration nullifies liability exclusion. A landowner is not liable as long as he has set no traps, no barriers, and received no valuable consideration.


A gift for the prior year is okay.
